

(S100) 2nd year DENTAL TECHNOLOGY PROGRAM NON-MEDICAL CERTIFICATES FORM (FALL TERM 2024)

Welcome 2nd year S100 Dental Technology students!

- In preparation for your dental practice both in-person and off-site, there are mandatory requirements that you will need to complete ahead of time. The Clinical Placement Office recommends that you begin gathering the necessary documentation now, in order to be able to submit them and provide enough time for the approval process.
- Once you have gathered all the necessary documents, you will need to create an account, upload and submit all documents, certificates and evidence to the ParaMed Placement Pass portal by the **given deadline on September 13, 2024**. A link to the portal can be found at <https://georgebrowncollege.placementpass.ca/>
- If you **fail** to complete, submit, and upload these requirements to ParaMed Placement Pass portal by the **given deadline on September 13, 2024**, you will be **excluded** from dental practice in clinic and lab which can jeopardize your academic standing & may lead to program **withdrawal**.
- All costs, service fees and fine associated with the overall medical and additional requirements are responsibility of the student.

Below is a summary of all requirements that must be provided in your submission. Please read and follow all the instructions carefully:

CPR level C Certificate (renew every year)

- All students must have a current CPR level C (renew every year), to participate in dental practicum valid every academic year.
- Please check the Peak Excellence website and scroll down to their Certificate packages for both WHMIS, SFA and CPR C certificates as they have a student discounted rates or you may register for this course at any WSIB Approved First Aid Trainers, for more information visit this link <https://www.georgebrown.ca/current-students/preplacement/additional-requirements/certificates> (fees apply)

ParaMed Placement Pass website

- Once you completed all the above requirements and officially registered to your Stu-View account, it is mandatory that you create an account, submit and upload it to the ParaMed Placement Pass portal **by September 15, 2023** at <https://georgebrowncollege.placementpass.ca/>

ParaMed Service Fees from June 1, 2022 to May 31, 2025

- Initial Submission Fee - \$59.47 dollars (submission of health form, RN fee, archives & medical access online)
 - Resubmission Fee (due to a Deficiency List Form) - \$26.10 dollars
- If you **fail** to do so, your academic coordinator will **exclude** you to be part of dental practice in the clinic and lab which will affect your academic standing in the program.

What is coming up next?

- ✓ For **3rd year in Fall 2025**- you will be required to process and complete a Prerequisite Health Form such as TDAP vaccination, MMR, Varicella, Hep B, Two Step TB Skin Test, CPR level-C and Mask Fit Test certificates as this is the requirement of the placement agency partners for your program before you will be allowed to practice in their facility.
