ELIGIBILTY

This award recognizes the contribution made by an individual or team demonstrating excellence in their work through actions of integrity and dedication, and an ongoing commitment towards the success of George Brown College and its communities. The nominee(s) are full or part-time employees from any employee group with a minimum of two years' service (or six semesters of teaching) who have not received the same award within the past two years.

The Nominee:

- Demonstrates an ongoing commitment to support George Brown College's Indigenous Initiatives department or their respective cultural spaces.
- Demonstrates a commitment to Truth and Reconciliation through their actions and practices.
- Has advanced the GBC Indigenous Education plan.
- Provides leadership and role models equity and inclusion.
- Promotes the Indigenous Initiatives department both within and outside of GBC.
- Demonstrates that their participation and commitment to George Brown College's Indigenous Initiatives department or their respective cultural spaces has had an impact on the George Brown College community. and beyond..
